## III.A. PRESENTATIONS

III.A.1. Course SLO Revisions for Academic Literacy and Linguistics:

Presenters: A. Judith Yancey, Ewa Barnes, Brian Kelley
Description: The SLOs for the following courses have been revised to reflect the Department and University move away from stand-along courses to co-requisite courses. Some courses also have additional changes as noted below.
III.A.1.1.1. $\quad$ ACR 95 Academic and Critical Reading II

Vote: Motion to approve the course revision passed 14-0-0.
III.A.1.1.2. CRT 100.5 Critical Thinking Corequisite for Reading Proficiency

This also includes: change of title, change of basic skills requirements and change of course description.

Required Revisions: Change basic skills requirements so that instead of "Index Score of 55 or above" it lists the range of scores. Remove reference to ACR 95 in SLOs and other areas of the syllabus.

V.A. Motion to approve blanket substitution in Spring 2020 of Proficiency Index scores for Reading, Writing and Math Basic Skills placements in all courses with the provision that each department must approve the substitution for the courses that department teaches.

The placements would happen in accordance with the English and Math Placement Chart.
If approved this motion will allow either the current placement test score or the Proficiency Index score to be used when determining if a student has met the Basic Skills requirements to enroll in a course.

The following resolution must be brought to and approved by a department in order for the English and Math Placement Chart to apply to that department's courses.

If the resolution is not passed by the department, then the department must submit individual course revision proposals for every course in the department or else students who only have Proficiency Index scores will not be able to take those classes.

1. VOTE: The motion passed 14-0-0.

## V.A.1. Resolution for the Departments to Approve

Effective spring 2020, for all credit-bearing courses requiring basic skills prerequisites, the academic department XXXXX approves of the College applying the appropriate proficiency index as a prerequisite.

## General placement guidelines:

to require that students are fully proficient, then:
English Index Score: 65 or higher
Math Index Score: 60 or higher
to require that students are in the higher-range basic skills, then:
English Index Score: 58-64
Math Index Score: 40-59
to require that students are in the mid-range basic skills, then:
English Index Score: 55-57
Math Index Score: 40-59

The lowest level of proficiency is *
English Index Score: 54 or lower
Math Index Score: 39 or lower
*Please note: Students with this proficiency index will need to enroll in CUNYStart, CLIP, BLIIS, basic skills lab program or a program offered by MEOC.
