- IV. STANDING COMMITTEE REPORTS FROM REPRESENTATIVES:
  - a. CURRICULUM COMMITTEE:
    - i. Course Revision: FRN 160 French Caribbean Literature in Translation **Description**: The proposal updates the course description to be more inclusive and flexible with the literature covered.

#### vii. Curriculum Revision: Science for Health Professions

**Description**: This proposal would change the name of the curriculum from *Science* for *Health Professions* to *Science for Health* and make a change to the program requirements. The name change should reduce confusion between this major and the Science major which is better for students seeking certain health professions.

#### viii. Curriculum Revision: Mathematics

**Description**: This revision changes the second Modern Language requirement to a Program Elective which changes the total Program Electives from 9 to 12. It also adds CSC 211 as a possible Program Elective and notes that students taking CSC 110 or CSC 111 may have CSC 101 count towards the General Elective.

#### ix. Curriculum Revision: AS in Art Foundations: Studio Art

**Description**: There are two changes to the Art Foundations curriculum requirements that add breadth and depth to our Studio Art Curriculum. Adding a new 3D Design course requirement aligns BMCC with most CUNY and other art degree programs. Also requiring students to choose either ART 174 Painting Studio I, ART 133 Photography I, or ART 183 Sculpture Studio I expands their skill set and better prepares them for transfer.

## **Faculty Development Resolution**

## **Resolution regarding Faculty Development Grant awarding process**

Whereas, the Faculty Development Grant was initiated, organized, and administered by the Faculty Development Committee of the Academic Senate to support full-time faculty to engage in scholarly and creative activities.

Whereas the Faculty Development Committee, after the submission to Academic Affairs of the list of proposed awardees selected through a rigorous CFP and Review process, is not aware of and excluded from the process of finalizing and notifying faculty awarded the grant.

Whereas the Faculty Development Committee is not informed of the funding source(s), amount of funding, and its allocation.

Be it resolved that the Faculty Development Committee calls for full transparency regarding the amount of funding available annually.

Be it resolved that the committee that conducts the grant review process retains the ability to determine which applicants receive awards and/or given a rationale where recommended applicants were unfunded.

Be it resolved that the Faculty Development Committee be kept abreast of the status of the disbursement of funds after the list of awardees are submitted to the college.

## **Instruction Committee Resolutions**

## Resolution concerning Peer Observations of remote teaching during pandemic

WHEREAS in April of 2020, the Academic Senate passed guidelines for peer observation of online courses that are aligned with the contractual procedures for online peer observations and

WHEREAS a large number of classes have exceeded enrollment of 25, which was agreed upon as the appropriate maximum number of students of for online instruction, and

WHEREAS many faculty members have not elected to teach remotely and have had very little experience training in remote instruction and,

WHEREAS no faculty member can assume instructional or pedagogical expertise in teaching in a remote environment in which students have not elected to learn in a remote environment,

BE IT RESOLVED that during this period where most instruction is remote, all peer observations only be used "formatively," for the benefit of the observed professors; and that these observations not be included in decisions concerning reappointment, tenure, or promotion, unless it is the expressed preference of the observed faculty member.

## **Resolution Concerning Student Evaluations of Teaching for Fall 2020**

WHEREAS many faculty members did not self-select to teach remotely and had very little prior experience and training in remote instruction, and

WHEREAS thousands of students currently in online courses had originally registered for face-to-face learning, and

WHEREAS the withdrawal date for students has been moved to the end of the semester, after Student Evaluations of Teaching (SETs) have been completed, contrary to past practices, and

WHEREAS the results of SETs influence decisions regarding reappointment, tenure and promotion, and

WHEREAS the Instruction Committee of the Senate has developed a new instrument to assess student experiences in the classroom, which can be offered to professors for their own private use this semester.

WHEREAS some junior and adjunct faculty may, despite the concerns above, wish to include student evaluations in their employment file,

BE IT RESOLVED that BMCC administer Student Evaluations of Teaching for the Fall 2020 semester only when requested by the faculty member. Because of the above-noted concerns, results of these evaluations should not negatively influence decisions concerning tenure, reappointment, or promotion.
