- III.A. NC/CR policy options: new options given after last AS meeting
 - 1. Allow the use of CR/NC grades for all Fall 2020 courses as in the Spring 2020 term.
 - 2. Allow the use of CR/NC grades for all Fall 2020 courses except those the college designates to be excluded.

3. Do not allow the use of CR/NC grades in Fall 2020 but expand access to the college's existing flexible grading policies using the University's <u>P/NC grading framework</u>.

- IV.A.6. FACULTY DEVELOPMENT COMMITTEE
 - 1. Faculty development day attended by 65 people. Feedback was overwhelmingly positive.
 - 2. Faculty Development Grant: committee has evaluation revised rubric. Committee does not yet know amount of money being set aside. Will put out call for proposals next semester.

- 1. Reviewed resolutions (Peer observations and Student evaluations) and voting result. Committee will not pursue revising the resolutions but recommend that AS issues a statement. IC will work with SAC to produce a statement draft.
- 2. Plans to focus on new student evaluation tool net semester.
- IV.A.8. ACADEMIC STANDING COMMITTEE
 - 1. Committee has processed approximately 2000 appeals this semester.
 - 2. Appeal system is now online but is time consuming and cumbersome. IT is creating a new system, which is in the demo phase.

IV.A.9. COMMITTEE ON STUDENT AFFAIRS

- 1. Met with R. Belle-Jerome there is a need for additional Panther Partner faculty coaches.
- 2. Continued work on *"Teaching in Crisis"* memo.
- 3. *Swap-fees charged to bursar*: planning on drafting a resolution that students should not be charged change fees in the first week of classes.
- 4. SGA donated \$28,000.000 funds to student emergency fund and scholarship fund.

IV.A.10. ADMISSIONS COMMITTEE

1. Discussed impact of distance learning on enrollment. Trying to determine whether a final decision has been made on F-2-F vs distance learning for Fall 2021.

IV.A.11. ACADEMIC FREEDOM COMMITTEE

- 1. Connect2Success emails: Met with Dean Zummo. Many faculty actually like the way emails are sent out. Will continue this investigation next semester.
- 2. Drafting a statement on the purview of this committee.
- 3. Reiterated that faculty have a role in deciding whether BMCC continues with Blackboard when contract ends December 2021.
