President's Fund for Excellence and Innovation

The work on distributing funds from the President's Fund for Excellence and Innovation (PFEI) towards projects and initiatives designed to improve student success continues. Updates include:

- The deadline for submission of letters of intent has passed and they are currently being reviewed by one of three subcommittees. A total of 61 letters were received.
- The three subcommittees (Teaching and Curriculum, Transformational Student Success, and Innovative Programs) are co-chaired by a Cabinet member and a faculty/staff member.
- Membership on the committees were based on those volunteering to serve (nearly 100 individuals submitted their names) as well as those elected by the College Council. Given that College Council provides representation for faculty, staff, and students, the decision was made to hold elections within this body.

President's Fund for Excellence and Innovation

- Applicants will be informed as to whether they are being asked to submit a full proposal on or before May 6th (updated date). The decision regarding invitation to submit will be based on committee evaluation and a workshop will be prepared to support the development of the proposals.
- The work of the PFEI Steering Committee and Technical Support groups will begin during the proposal stage and final decisions regarding the awarding of funds will be made by the Steering Committee during the month of June.
 Additionally, the Steering Committee will be meeting in May to prepare for the review and in June to make the final funding decisions.
- The College will continue to consider suggestions from the campus community
 and will review the processes and practices regarding the President's Fund. The
 addition of faculty/staff co-chairs and the inclusion of College Council elections
 reflect changes made based on community input.

Fall '21 Enrollment Projections

Factors Impacting Fall '21 Enrollments New Students

- Compounding factors of pandemic and declining high school grad populations
 - Fewer high school grads choosing college (-22% national data)
 - High school grad rates peaked for New York in 2019 (WICHE)
 - Benefit of increase of NYC High School grad rates diminishing
 - NYC High School Grad rates have increased by 24% over the past 10 years
 - CUNY enrollments increased 52% because of this increase in high school grads
- Location Point-of-Difference no longer an advantage
 - Connection to the Subway system
 - Commuting to Manhattan not as appealing post-pandemic
- Applications down significantly
 - Freshman 20%
 - Transfer 30%

Factors Impacting Fall '21 Enrollments Continuing Students

- Will our modality match demand
 - 50% of students indicate they want F2F classes or mix of options
 - Can F2F capacity match demand
- How will fear of commuting and fear that others will not comply with safety regulations impact enrollments
- Retention and probation rates have remained the same over past five years


Update on Vaccinations

Vaccination Sites on CUNY Campuses: Currently there are three City-run vaccination sites on the following CUNY campuses: City College, Lehman College, and Queensborough Community College. Vaccines are available at these locations to CUNY faculty, staff and students as well as neighboring CUNY campuses.

City Vaccination Sites Open to Walk-ins: As of April 23rd, all City-run COVID-19 vaccination sites, including those on the above three mentioned CUNY campuses, are now open to walk-in appointments.

- All New Yorkers eligible for the vaccines can participate.
- Only those ages 16 and older can receive the Pfizer vaccine, and only those ages 18 and older can receive the Moderna vaccine.
- The expansion to all eligible New Yorkers is limited to sites run by the city's health department and its public hospital system.


Updated CDC Guidance for Fully-Vaccinated People


