## Academic Freedom Committee Resolution

Whereas the Academic Senate does not have sufficient time to deliberate properly on the many issues facing the college;

Whereas the College Cabinet and the Academic Senate previously decided that a new Governance Plan should be written to reform it as a unicameral body;

Whereas the cabinet and the senate constituted ad hoc committees to rewrite the Governance Plan;

Whereas the Governance Plan was in its final draft form to restructure the academic senate so that it is a unicameral body;

Whereas that process was halted because the interim President was felt it was improper for an interim President to bring a new Governance Plan to the Board of Trustees;

Whereas BMCC now has a President in place;

Be it resolved that the Academic Senate reconstitute an ad hoc committee to finalize the new Governance Plan.
