The term 'humanities' includes, but is not limited to:

- ✓ Language, both modern and classical;
- ✓ Linguistics;
- ✓ History;
- ✓ Jurisprudence;
- ✓ Philosophy;
- ✓ Archaeology;
- ✓ Comparative religion;
- ✓ Ethics;
- ✓ The history, criticism and theory of the arts;

- ✓ Those aspects of social sciences which have humanistic content and employ humanistic methods; and
- ✓ The study and application of the humanities to the human environment with particular attention to reflecting our diverse heritage, traditions, and history and to the relevance of the humanities to the current conditions of national life.

BEFORE YOU GET STARTED...

Read Previously Funded Proposals

Read previously funded proposals or abstracts for the agency to which you are submitting your grant. The National Endowment for the Humanities offer complete sample applications of previously funded proposals on their websites. Knowing what a good grant looks like helps in crafting your own grant application.

✓ Read the Guidelines

Carefully read the application guidelines. They contain valuable information, including how to assemble your grant, the review criteria, types of activities supported, and all the necessary details that need to be followed in order to be funded. Many grants are eliminated during

the first phase of the review process simply because the guidelines were not followed.

✓ Know the Audience

Know the audience for whom you are writing. Are the reviewers specialists in your field, or are they familiar with your area, but not necessarily experts? Will panels be interdisciplinary or multidisciplinary? Will the funding agency send your proposal to individual outside experts or will the review take place inhouse? Knowing your audience is key to knowing how to write your proposal.

✓ Talk to the Program Officer

Contact and ask questions of the Program Officers at the funding agency. Often, they will review a two or three page concept paper of your proposal and give important advice. These should be submitted at least

six weeks prior to the grant deadline, so that the staff will have time to reply, and you will have time to make any necessary alterations to your project.

✓ Address Four Key Questions

A proposal should clearly answer four main questions: 1. What are you going to do? 2. How will you do it? 3. Why is it significant? 4. Why are you the right person to do it?





NATIONAL ENDOWMENT FOR THE HUMANITIES




- Promotes progress and scholarship in the humanities.
- Supports research in the humanities, nurturing the nation's humanities infrastructure, and expanding the reach of the humanities to all Americans.
- Enables individuals and institutions across the United States to study, preserve, and share the best of America's history and culture.

NEH GENERAL REVIEW CRITERIA

General NEH Review Criteria (Specific review criteria may vary across programs)

- Humanities significance includes the project's value to humanities scholars, general audiences, or both
- Applicant's abilities and qualifications as an interpreter of the humanities
- Proposal's clarity of expression –
 definition, organization, and description of
 the project
- Project's feasibility, design, cost, and work plan – includes soundness of dissemination and access plans, and the likelihood that the applicant will complete the project.



These awards strengthen the humanities at HSIs by encouraging and expanding humanities research opportunities for individual faculty and staff members.

Funding for developing new or enhancing existing programs, resources (including those in digital format), or courses that **explore**, **interpret**, **and preserve** the diversity of human cultures, ideas, and practices, past and present.

Projects must address a core topic or set of themes drawn from humanities areas such as history, philosophy, religion, literature, or humanities-informed composition and writing skills.

NEH welcomes applications for projects that are modest in scope, duration, and budget, as well as applications for expansive, long-term projects.

Note: Narrative attachments may not exceed 8 single-spaced pages.

Situating Ourselves in the Salish Sea: Using Experiential Learning and Storytelling to Inspire Critical Thinking about Place

Summary/Abstract:


Whatcom Community College (WCC) proposes Situating Ourselves in the Salish Sea: Using Experiential Learning and Storytelling to Inspire Critical Thinking about Place to engage students and faculty in the practice of placebased teaching and learning. Located adjacent to the Salish Sea, two Native American reservations, and 15 miles from the Canadian border, WCC is perfectly situated to embark on a project utilizing digital mapping

technology to investigate and contextualize the cultural heritage of this region.

Funding for: Course redesign, faculty reading groups, digital humanities software

Included an embedded video





The Digital Projects for the Public program supports projects that interpret and analyze humanities content in primarily digital platforms and formats, such as websites, mobile applications and tours, interactive touch screens and kiosks, games, and virtual environments.

All Digital Projects for the Public projects should present analysis that deepens public understanding of significant humanities ideas; incorporate sound humanities scholarship; involve humanities scholars in all phases of development and production; include appropriate digital media professionals; reach a broad public through a realistic plan for development, marketing, and distribution; create appealing digital formats for the general public; and demonstrate the capacity to sustain themselves.

Application available: March 14; Deadline: June 14; Project Start Date: March 2024

<u>Example:</u> iCivics (\$400,000) iCivics proposes a new civics and history education gaming experience, earmarked for young people ages 12-18. This project is a unique in its approach to teaching critical humanities skills. iCivics will partner with Gigantic Mechanic to design, create, and disseminate Supreme Justice – an interactive classroom experience meant to promote civil dialogue, civic and historical knowledge ... and engage students. Supreme Justice is a multi-media experience.

ANATOMY OF A TYPICAL NEH GRANT

1. Narrative

In no more than three singlespaced pages with one-inch margins, describe the project's

- Significance and contribution
- Organization, concepts, and methods
- Competencies, skills, and access
- Final product and dissemination

2. Work plan

In no more than one singlespaced page with one-inch margins, provide a work plan (in increments of three months or fewer) describing what will be accomplished during the period of performance (full-time commitment), where you will be, and how you will spend your time. If you do not anticipate finishing the entire project during the fellowship period, discuss your plan for doing so.

3. Bibliography

In no more than one singlespaced page with one-inch margins, list key primary and secondary sources that relate directly to the project.

4. Résumé

In no more than two pages,

provide information on

- current and past positions
- education
- awards and honors
- publications
- other relevant professional activities and accomplishments
- level of competence in any relevant foreign languages.

(*Note* that a conventional academic curriculum vitae is not acceptable.)



Examples of Funded NEH Proposal Narratives






FUNDING OPPORTUNITIES FROM FOUNDATIONS

PRIVATE FUNDING FOR THE HUMANITIES

A varied universe of private funders supports a wide range of humanities projects and organizations.

- National foundations maintain programs with priorities in the humanities.
- Local or regional foundations invest in projects relevant to communities in geographic areas of interest.
- Independent associations/councils award small grants and fellowships within disciplinary focus areas.



The Teagle Foundation believes that all students, regardless of major, should have an opportunity to experience the liberal arts. The Foundation works to support and strengthen liberal arts education, which it sees as fundamental to meaningful work, effective citizenship, and a fulfilling life. The aim is to serve as a catalyst for the improvement of teaching and learning in the arts and sciences while addressing issues of financial sustainability and accountability in higher education. The Foundation is based in New York but makes grants nationally, focusing on seed funding to extraordinary educators with concrete solutions to urgent challenges. It is expected that supported projects are aligned with institutional priorities, and that grantee institutions will seek to sustain successful initiatives beyond the life of the grant. Grants can be either for planning or implementation.


DEADLINE

Three annual deadlines: December 1, March 1, and August 1.

AWARD SIZE

Planning grants: \$25,000 for 6-12 months

Implementation grants: \$100,000-\$400,000 for 2-3 years



The Hearst Foundations are national philanthropic resources for organizations working in the fields of culture, education, health and social services. Within education, the Foundation funds educational institutions demonstrating uncommon success in preparing students to thrive in a global society. The foundation's focus is largely on higher education, but it also funds innovative models of early childhood and K-12 education, as well as professional development. Priorities include program support, scholarships, college access and success, professional development for educators, and science education. Support is occasionally given for endowment or capital requests.

DEADLINE

Rolling applications. No deadline.

AWARD SIZE

Most grants to higher education range from \$50,000 to \$200,000, although BMCC should not ask for more than \$100,000.

SMALL HUMANITIES GRANT OPPORTUNITIES: FORECASTING

Prepared for CUNY Borough of Manhattan Community College

In the following report, Hanover Research provides a breakdown of funding prospects aligned with the interests of CUNY Borough of Manhattan Community College.



EXECUTIVE SUMMARY: KEY FINDINGS

The CUNY Borough of Manhattan Community College (BMCC) has sought assistance identifying local, moderately-sized funding opportunities for educational activities within the humanities broadly. The college seeks support for a range of activities including faculty research and travel, student education and enrichment, pedagogical research, tutoring, and program support. Our research into the most suitable funding opportunities for this project led to the following notable funders and key findings.

KEY FINDINGS: PROSPECTS

We profile 30 foundations that have strong giving interests in New York and New York City, frequently give to higher education, and are likely to give \$5,000-\$50,000 in support (although most will also give outside this range, too). Nine of these foundations have given to BMCC before. We include six national-level foundations and an additional six federal programs whose giving priorities fit the needs of BMCC.

- The Booth Ferris Foundation, Charles Hayden Foundation, Nomura America Foundation, John Ben Snow Memorial Trust, and Teagle Foundation are particularly well-aligned, new matches for BMCC.
- The Carroll and Milton Petrie Foundation, James T. Lee Foundation, Stonewall Community Foundation, Herbert and Audrey Rosenfield Fund, Annette Urso Rickel Foundation, Ernst & Young Foundation, Shawn Carter Scholarship Fund, Wesley Parrott Youth Programs, and New York City Community Trust have given to BMCC before and are worth approaching again.
- The Hearst Foundation, Deutsche Bank Americas Foundation, Ford Foundation, Sloan Foundation, Bloomberg Philanthropies, and American Council of Learned Societies (ACLS) are larger, national-scale organizations that BMCC should also consider.
- We also profile three opportunities with the National Endowment for the Arts (NEA) and three with the National Endowment for the Humanities (NEH). Many of these are excellent opportunities for individual faculty research.

KEY FINDINGS: MARGINAL

We also identify 11 marginal funding opportunities:

- The <u>Achelis & Bodman Foundation</u> primarily makes grants to elementary and secondary educational institutions, but it did make one award to BMCC in 2020.
- The Atlantic Yards Nets DBNA Community Foundation (no website) has a strong interest in remedial education, but historically does not support institutions of higher education.
- The North Star Fund has given repeatedly to BMCC (most recently in 2020) but is more interested in social justice and activism than higher education.
- The Michael Wolk Heart Foundation (no website), Marshall Family Foundation (no website), and Coleman Foundation (no website) all gave to BMCC between 2016 and 2020, but generally give more to health and medicine-related causes.
- BMCC should consider reestablishing a relationship with the Philip and Tammy Murphy Family Foundation (no website). The Foundation gives only to preselected organizations, has an interest in education, and gave to BMCC in 2016.



EXECUTIVE SUMMARY: OVERVIEW OF FOUNDATION PROSPECTS (1 OF 5)

FUNDERS PROFILED IN THIS REPORT

For each of the opportunities reviewed in this report, we evaluate viability based on alignment with funder focus areas and funding history, in addition to providing background information necessary for developing an approach. The summary tables in the following slides provide an overview of key information regarding the opportunities reviewed in this report. While our research suggests that the funders profiled below are strong fits based on focus area alignment and funding history, an approach to each funder should take into account not only the published guidelines, but the need to establish contact: in all cases, we recommend that the Borough of Manhattan Community College reach out to a relevant staff member to discuss project scope and parameters before developing an approach.

The ACLS is the leading private institution supporting scholars in the humanities and related social sciences at the doctoral and postdoctoral levels. Given the disproportionate effect the current economic downturn has had on emerging, independent, and untenured scholars, ACLS will continue in the 2021-22 competition year to offer these fellowships solely to untenured scholars who have earned the PhD within eight years of the application deadline. ACLS welcomes applications from scholars without faculty appointments and scholars off the tenure track. In addition to ACLS Fellowships, which provide full-time support to researchers in all disciplines of the humanities and related social sciences for the production of a major piece of scholarly work, ACLS offers several other competitions, each with specific eligibility requirements and deadlines.


