- BMCC MUST SET ANNUAL TARGETS
   The college must set annual performance targets and identify strategies to make progress on 18 of the University's Key Performance Indicators (KPIs) Submitted prior to the October 6 Deadline

#### **Student Affairs Announcements**

- Men's and Women's soccer teams both won the CUNYAC championship.
  - The Women won the first ever CUNY Women's Community College Soccer championship 7-0 over QBCC
  - The Men defended their championship title 3-2 over KBCC.
- Petrie Foundation has approved additional funding for the BMCC-Trinity Dorm Program in the amount of \$45,000





#### **Student Affairs Announcements**

- Amazon is contributing \$25,000 to support the BMCC Food Pantry.
- CUNY collaboration with the Hope Center at Temple University on a study of college transportation initiatives
  - 265 BMCC students will be recruited to participate in this study during the fall 2023 and spring 2024 semesters.
- The Petrie Foundation data on BMCC's 2022-23 Student Emergency Assistance:
  - 3.6% of BMCC students requested emergency assistance, higher than CUNY's 2.4% average.
  - BMCC received 631 applications totaling over \$1.4 million, second-highest in CUNY.
  - BMCC awarded nearly \$240,000 to 506 students.
  - BMCC's median award was \$500, matching CUNY's average.
  - 80.2% of BMCC applications were approved, the highest in CUNY (43% CUNY-wide).
  - Top emergencies: 47% loss of job and income
  - Top need: 59% housing/rent.

#### **Student Affairs Announcements**

- BMCC received \$39,761 from the CUNY-wide LGBTQIA+ Consortium, that is funded by the New York City Council, thanks to Brian Kelley and Yuliya Shneyderman.
  - stipends for students to participate in different activities; acquire books; fund miniprojects through the library, bring guest speakers to campus; provide stipends for 30 faculty members to participate in related trainings

#### ETHICS TRAININGS

Ethics Commission Reform Act of 2022 changed Executive Law Section 94(a) to mandate that all state officers and employees must complete live comprehensive ethics training every two years and an online refresher course in the intervening year

For purposes of ethics law, BMCC employees are state employees Refresher course not yet available.

Previously, training was only required for employees who were required to file Financial Disclosure Statements as academic filers and/or policy makers.

The same training is being offered periodically each month. Please check your email for new training dates.
