# PSC-CUNY Research Award Program Grants Officer Quick Reference Sheet for Cycle 56

# **Eligibility**

# Is the applicant eligible?

- CUNY
- Permanent
- ✓ Full time

### **Tenure Status**

- If tenured, an applicant may only receive 2 awards in any 3 year period, only 1 may be an Enhanced.
- Untenured have no such restriction.
- For cycle 56, the three-year period is cycles 54, 55 & 56.

# **Other Funding Sources**

- Applicants with over \$100,000 in direct costs for the period of the grant (July 1<sup>st</sup> 2025 through June 30<sup>th</sup> 2026) are INELIGIBLE to apply for TRADA or TRADB.
- Co-PI's share half the total, unless otherwise stipulated
- When considering multi-year awards, divide total direct costs by number of years.

# Multiple Applicants

- Co-PIs must meet all eligibility criteria.
- One application per person, per cycle, as either PI or Co-PI: applicants cannot apply as a PI and a Co-PI in the same cycle.
- Co-PIs are **NOT** eligible for Released Time or Summer Salary.

#### Final Things to Look Over

- Does the applicant meet the eligibility requirements?
- Are all expenses properly justified?
- Does the Budget section of the Abstract match the Project Description (or Detailed Budget Justification)?
- Are all budget items explained and justified?
- iPads and other computer purchases are restricted but permissible if properly justified.
- Tuition or stipend payments are not allowable.
- eReaders (Kindles, Nooks, etc.) are not allowable.

## **Budget Area Hints & Double-Checks**

#### **DOMESTIC & FOREIGN TRAVEL:**

- All research related travel is reimbursable for up to 60 days, provided that travel AND purchases occur within project period.
- Travel purchases can be made starting May 1<sup>st</sup> 2025 however, physical travel cannot occur until the start date, July 1<sup>st</sup> 2025.
- RF adheres to U.S. State Department per diem rates, regardless of requested amount.
- RF only permits reimbursement for U.S Flag air carriers, the only exceptions are authorized European carriers per the U.S.-EU Open Skies Agreement (<u>European Union</u> <u>Countries</u>) or on a Swiss, Australian or Japanese's carrier airline carriers.
- Conference travel is allowable and may include transportation, lodging, meals and registration.

#### **RELEASED TIME**

- Flat amount: salary = \$3,000, fringe = \$1,482
- TRADA cannot support Released Time

#### **SUMMER SALARY**

- Maximum annual salary (including expected Summer Salary) is \$107,789.00.
- Maximum request for Summer Salary is \$3,500
- TRADA: salary = \$2,811, fringe = \$688.70
   TRADB & ENHC: salary = \$3,500, fringe = \$857.50
