# PSC-CUNY Research Award Program Grants Officer Quick Reference Sheet for Cycle 57

# **Eligibility**

## Is the applicant eligible?

- ✓ CUNY
- Permanent
- ✓ Full time

### **Applicant Restrictions**

- There are no tenure restrictions
- All Applicants my receive 2 awards in a 3-year period.
   Only one of which may be Track 2.

## **Other Funding Sources**

- Applicants with over \$100,000 in direct costs for the period of the grant (July 1<sup>st</sup> 2026 through June 30<sup>th</sup> 2027) are INELIGIBLE to apply.
- Co-PI's share half the total, unless otherwise stipulated
- When considering multi-year awards, divide total direct costs by number of years.

# **Multiple Applicants**

- Co-PIs must meet all eligibility criteria.
- One application per person, per cycle, as either PI or Co-PI: applicants cannot apply as a PI and a Co-PI in the same cycle.
- Co-PIs are **NOT** eligible for Released Time or Summer Salary.

# Final Things to Look Over

- Does the applicant meet the eligibility requirements?
- Are all expenses properly justified?
- Does the Budget section of the Abstract match the Project Description?
- Are all budget items explained and justified?
- iPads and other computer purchases are restricted but permissible if properly justified.
- Tuition or stipend payments are not allowable.
- eReaders (Kindles, Nooks, etc.) are not allowable.

### **Budget Area Hints & Double-Checks**

#### **DOMESTIC & FOREIGN TRAVEL:**

- All research related travel is reimbursable for up to 60 days, provided that travel AND purchases occur within project period.
- Travel purchases can be made starting May 1<sup>st</sup> 2026 however, physical travel cannot occur until the start date, July 1<sup>st</sup> 2026.
- RF adheres to U.S. State Department per diem rates, regardless of requested amount.
- Conference travel is allowable and may include transportation, lodging, meals and registration.

#### **RELEASED TIME**

- For Academic Year 2025-2026: \$6024.60 (3-credit);
   \$7530.75 (4-credit)
- Track 1 applicants are able to receive release time this year

#### **SUMMER SALARY**

- Maximum annual salary \$7000 or \$15000 depending on application. (including fringe)
- PIs subject to Article 14.1 of the collective bargaining agreement may not receive summer salary greater than 3/9 of their gross annual salary and may not receive compensation in a given month (June, July, August) greater than 1/9 of their gross annual salary.
- These rules are subject to change from the PSC and CUNY
