President's Report College Council October 22, 2025

ENROLLMENT

Spring 2026 Update (As of October 20, 2025):

- 29.1% increase in applications (6,281 vs 4,864) or 1,417 more applications
- 73% increase in accepted students (812 vs 468) or 344 more accepted students

Fall 2025 (October 15, 2025) Open House:

- 21.9% increase in registrations (1,564 vs 1,283) or 281 more registrants compared to last year
- 13.5% increase in attendance (520 vs 458) or 62 more attendees compared to last year

Recruitment (September - Present) Open House:

College Tours:

- 308% increase in registrations (1,065 vs 261) or 804 more registrants
- 323% increase in attendance (550 vs 130) or 420 more attendees

Admissions Information Sessions:

- 14% increase in registrations (308 vs 270) or 38 more registrants
- 3% increase in attendance (119 vs 115) or 4 more attendees



ACADEMIC AFFAIRS

- Progress reports allow you to share positive feedback through kudos. Data from 2022–2024 shows that high GPA students who received kudos re-enrolled at rates 8–10% higher than those who did not, highlighting the lasting impact of positive recognition on persistence.
- Progress reports also connect students to academic support services: students who
 received alerts and attended tutoring re-enrolled at rates 13–16% higher than
 those who never engaged, underscoring the powerful role of early referrals in
 student success.

Together, these trends underscore the powerful role of both positive recognition and early intervention in supporting student persistence and success.

ACADEMIC AFFAIRS

Five Pillars of CUNY Beyond

- Exploration & Exposure
- Integrated Advising
 - Develop career-infused degree maps that add professional milestones to the traditional list of courses required to obtain a degree.
 - Hire integrated academic & career advisors to be embedded within different academic departments, starting with high-demand disciplines, and equipped with written resources.

Career-Connected Learning

- Identify courses on rapidly evolving topics to be taught by industry adjuncts in in-demand sectors through Practitioners In Residence Corps.
 - Deliverables: Develop courses co-taught by industry professionals. Use current models in Accounting, Business, Computer Science, and Health Education to develop courses in 5-7 other academic programs.

STUDENT AFFAIRS

Federal Funding - CCAMPIS Grant

- Unfortunately, the current administration has decided not to hold a Child Care Access
 Means Parents in School (CCAMPIS) Federal Grant competition this year. Currently, the
 BMCC childcare center receives \$464,000 annually from this source.

Federal Funding - Conexiones

- The Conexiones cohort program provides bilingual, culturally relevant services to support the retention, graduation, and transfer of Latino male and low-income students.
- We recently received approval for a no-cost extension from the federal government. This
 additional time allows us to complete all allowable grant activities and meet the program's
 goals and objectives. Please continue to encourage students to participate.

Affordable \$5 Meal Program

- At President Munroe's request to reduce food costs for our students, the cafeteria is now
 offering a \$5 bowl that includes a protein and a starch or vegetable. This affordable meal option
 is available to students, faculty, staff, and all cafeteria users.
- To further support this initiative, the College will support ARC for the Center to provide \$5
 vouchers to students to help them purchase the bowl, advancing our goal of making meals
 accessible to all members of the College community.

Housing Supported by Trinity

- At the end of the last academic year, the program faced closure due to the depletion of the \$2 million Trinity Funds.

INSTITUTIONAL ADVANCEMENT

- Current total FY26 cash contributions \$644,481 including
 - \$170,000 for BMCC as part of the approved Trinity Church NYC modification award to the Borough of Manhattan Community College Foundation: Housing for Homeless BMCC Students Program
 - \$157,874 in additional scholarships and scholarship program match funding
 - \$25,000 contribution from Pfizer and partnership with Pfizer Early Careers program. Working with Office of Internships & Experiential Learning
- Additional \$135,000 in pledges from individuals, \$2,090,000 in pledged contributions from other organizations
- CUNY Tuesday Annual Fund Giving Campaign program information launch September 23, 2025
 - BMCC: "Learning to Serve, Serving to Learn: Empowering the World Together"
- BMCC Foundation Board has made the decision to postpone the October 28, 2025, BMCC Foundation Scholarship Gala to Spring 2026

OFFICE OF SPONSORED PROGRAMS

\$1.5 Million in Recent Grant Awards

- \$269,401 over two years from NSF to Prof. Garte, for the implementation of an NSF Computer Science for All grant titled, *Embedding computational thinking into school-wide curriculum: leveraging professional learning communities at a pre-K to 5th grade school.*
- \$58,820 to Professor Joanna Giza for the fifth year of participation in the City
 College of New York's National Institutes for Health Manhattan-Bridge Program.
 This scholarship and support program seeks to enhance the number of
 underrepresented students in biology and psychology sciences research by
 bridging the path from an associate degree at BMCC to a baccalaureate degree in
 a STEM field at CCNY. Both BMCC and CCNY are minority-serving institutions.

OFFICE OF SPONSORED PROGRAMS

- \$218,000 was awarded from the NYC Council to BMCC's Adult Literacy program
 to support the English language attainment of adult learners.
- \$962,904 has been awarded to AVP Allison Messina to implement a Sterile
 Processing Technician Training & Employment Pipeline with CUNY FY2026 WDI
 Contract Courses/Workforce Development funding. The grant will enable 80
 people to be trained over the next three years.
- \$15,000 over one year to Prof. Mohammad Azhar from the New Venture Fund's
 Public Interest Technology University Network (PIT-UN) to implement a 2025-2026
 PIT-UN Tech for Change Hackathon with BMCC students.
