### **Election to College Council Standing Committee**

It is BMCC tradition that the club hours of the first Wednesday of every month, is designated for use for the meetings of the standing committees of the college governance bodies. Since this time is used by the committees of both the College Council and the Academic Senate, it is difficult to impossible for a faculty person to serve on both a College Council standing committee and an Academic Senate standing committee. For this reason, the college governance body voted a few years ago to recommend that the governance charter be amended to provide

that the faculty members of College Council standing committees shall not be assigned to serve on an Academic Senate standing committee. This recommendation was accepted and it is now contained in the governance charter and may be found at Article I, Part A, Section 5(a) of the charter. Accordingly, faculty elected to serve on a College Council standing committee in 2013-

2014 will not be assigned by the Academic Senate Committee on Committees to an Academic

Senate standing committee during the 2013-2014 academic year.

### Election to Academic Senate Committee on Academic Standing

The Academic Standing Committee is the only Academic Senate standing committee that must hold some meetings over the summer to fulfill one of its committee responsibilities, the reading and ruling on appeals filed by students on matters that relate to academic standing.

The current chair of the Academic Standing Committee, for planning purposes, and based on the deadline for students to file appeals, has designated the two week period from July gth through July 18th for the reading of appeals.<sup>1</sup> Please keep these dates in mind if you are asked to serve on the 2013-2014 Academic Standing Committee.
