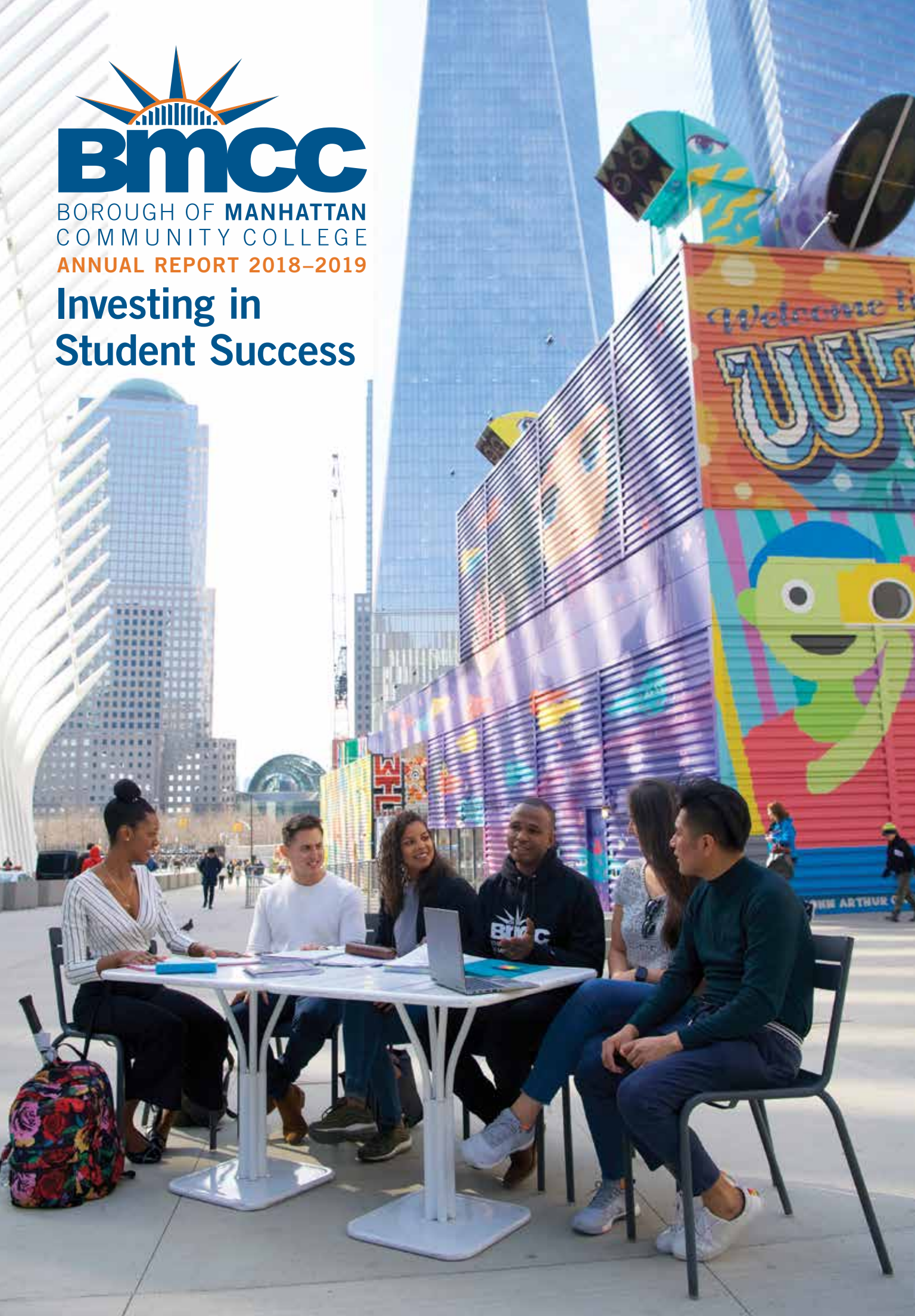

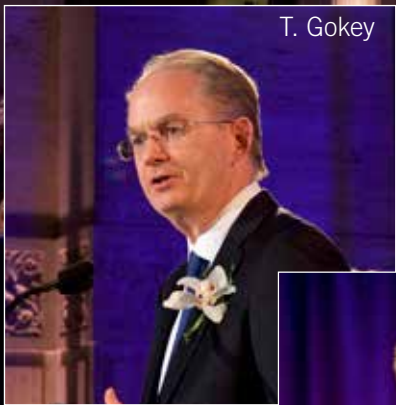

The BMCC Foundation Board of Directors hosted the 2019 Gala, *Invest in a Future, Celebrate Success* on May 16 at Cipriani, 25 Broadway in lower Manhattan. The event was emceed by Fox 5 News personality Baruch Shemtov. The 2019 Gala Honorees were Tim Gokey, CEO of Broadridge Financial Solutions, Inc. and The Herbert and Audrey Rosenfield Fund. Dr. Antonio Pérez, former president of BMCC, was recognized for his leadership in the creation of Out in Two, which he founded in 1999 in response to criticism of community college graduation rates.

The gala program celebrated its 20th anniversary of Out in Two and its two-year graduation rate of 84 percent, a much higher rate than the national average of 22 percent over three years. This year's special guest artist honoree was Ashley Boudier, founder and director of the Ashley Boudier Project and principal dancer, New York City Ballet. "Our May 16 BMCC Foundation Gala, Invest in a Future, Celebrate Success, was successful in many ways, raising \$922,000 for scholarships and winning new friends and supporters for BMCC and our students," said Doris Holz, vice president of development and chief operating officer of the BMCC Foundation. A highlight of the evening was the announcement of a \$1 million gift to the BMCC Foundation from The Herbert and Audrey Rosenfield Fund to support BMCC's Out in Two Program.

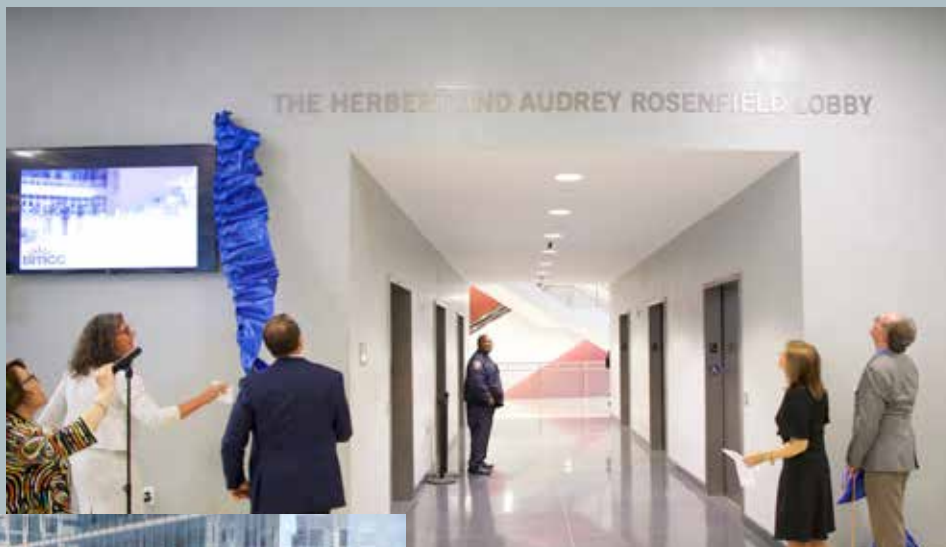

BMCC NAMES HERBERT AND AUDREY ROSENFIELD LOBBY

On Monday, May 20, a lobby-naming ceremony and reception were held to honor a landmark gift of \$1 million for the BMCC Out in Two program, from the Herbert and Audrey Rosenfield Fund. The event also

honored the Rosenfield family, important contributors to the growth and cultural vibrancy of lower Manhattan, and long-term supporters of successful scholarship programs and initiatives at BMCC. Before signage commemorating The Herbert and Audrey Rosenfield Lobby was revealed, speakers included Tom and Patricia Rosenfield, who along with their brother Nelson continue to keep their parents' legacy alive. The lobby is located on the first floor of the Miles and Shirley Fiterman Hall, and Patricia Rosenfield opened her remarks by thanking the Fiterman family, "and my BMCC Foundation Board colleagues Steven and Miles Fiterman, for the honor of permitting our family to be associated with theirs. This is a very special happening that doesn't take place too often." More than a hundred BMCC administrators and close family friends of the Rosenfields, as well as colleagues including Raymond O'Keefe—a lifetime friend of Herbert Rosenfield and co-founder, with Mr. Rosenfield, of the BMCC Foundation—gathered in the lobby as the event began.

"Our parents envisioned that Borough of Manhattan Community College should become the anchor institution for maintaining a vibrant community in downtown Manhattan, especially after the new World Trade Centers were built in 1974," said Patricia Rosenfield. "Not only has the college nurtured the talents and lives of so many deserving New Yorkers, but it has enriched an entire community with its educational programs, its fabulous art exhibitions, its music performances and its stunning architecture represented by the beautiful Miles and Shirley Fiterman Hall built on a deeply historic educational site. We are all celebrating Borough of Manhattan Community College and its enduring contributions to New York City and far beyond."

OUT IN TWO PROGRAM CELEBRATES 20 YEARS OF SERVING STUDENTS

On June 13, BMCC celebrated the 20th Anniversary of the Out in Two scholarship program with a special alumni reunion at Fiterman Hall. The event included live music from The BMCC Jazz Ensemble—Seth Hershman on keyboard, David Milkis on cello and Nova Luz, vocals. Out in Two is an academic program through which students graduate from BMCC within two years. To be eligible for Out in Two, students must be enrolled in a BMCC degree program as a freshman, and have completed 12 credits with a 3.0 minimum GPA. Program benefits include scholarship support, a dedicated academic advisor, a supportive community and trips to senior colleges. “Out in Two is a very significant program designed by my predecessor, BMCC President Antonio Pérez,” said BMCC Interim President Karrin E. Wilks. “Out in Two is based on the highly successful cohort model. The program has shown an unprecedented rate of graduation—almost 90 percent within three years.”

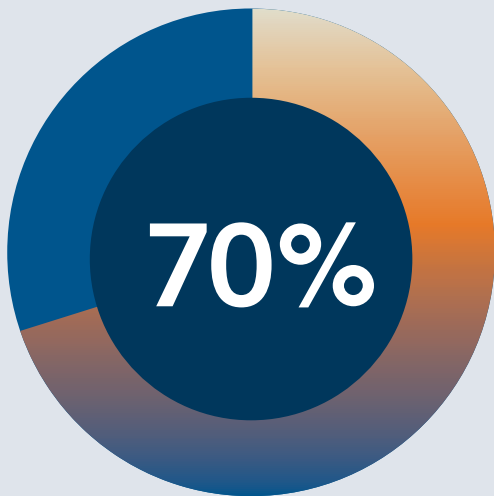

BMCC, along with Hudson County Community College, New Jersey City University and St. Peter's University are partners in the program led by Goldman Sachs Group, Inc., which helped create the curriculum as part of the firm's commitment to support local students and colleges, and to assist workforce development. The participants, including 10 BMCC students, met during the six-month program to formulate a solution to a designated real-world business challenge, and crafted their response with feedback from Goldman Sachs as well as BMCC executives and professional staff.

RE-ENTRY/ENTRY SYMPOSIUM ADDRESSES JUSTICE-INVOLVED STUDENTS AND SETS FOUNDATION FOR PROJECT IMPACT

More than 100 attendees gathered for the Re-Entry/Entry Symposium, Pedagogy, Programs and Policies that Support and Sustain Justice-Involved CUNY Students on May 3 at the Conference Center at Fiterman Hall. The day-long event was sponsored by BMCC along with the University Faculty Senate's Committee on Higher Education in Prisons, and was made possible by a grant from Trinity Church Wall Street. Participants shared research, best practices, knowledge and experiences. The Re-Entry symposium is part of ongoing efforts at BMCC to serve justice-involved students.

According to BMCC Human Services Professor Lisa H. Rose, the impetus for the symposium took place at BMCC in March 2017, when she convened a meeting to start discussions of a concerted, supportive response to the needs of justice-involved students. From there, Project Impact was established to serve students with a history of criminal justice involvement and others seeking education and career opportunities. Project Impact at BMCC seeks to identify justice-involved students who are enrolled in an associate degree program at the college, or who are seeking to earn a High School Equivalency (HSE) diploma and then enroll at BMCC. The students will have access to peer mentoring, tutoring, counseling, career development and other resources. Most importantly, they will belong to a small cohort and close community of support.

Funding for Project Impact was kicked off by a donation of \$15,000 each from BMCC Foundation Board members Elizabeth Butson and John Sutter. Project Impact also received a foundation grant from the Pinkerton Foundation, the BMCC Foundation, the Black Male Initiative (BMI) and CUNY —altogether, totaling \$200,000. The project is seeking additional funds to support and expand the program through the end of 2020. Eventually, the program could be replicated across CUNY, providing students with the education, support and skills they need for a second chance at success.

PILOT PROGRAM HELPS BMCC STUDENTS IN FINANCIAL NEED

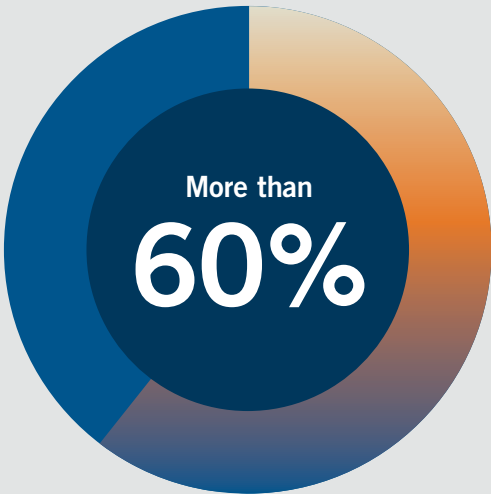
BMCC has a pilot program, funded through a \$100,000 grant from the BMCC Foundation, which allows stopped-out students with financial holds to return and obtain their degree with a completion grant that pays down half of their outstanding balances.

PANTHER PANTRY SERVES STUDENTS WITH FOOD INSECURITY

Students experiencing food insecurity can find support at the BMCC Panther Pantry, located in Single Stop at 199 Chambers Street, Room S-230. The Panther Pantry provides nutritionally balanced, nonperishable food for students in need. The Pantry also helps students connect with the Supplemental Nutrition Assistance Program, or SNAP. Single Stop is currently working with the BMCC Foundation to create a donation process and policy, in compliance with Food Bank guidelines.

BMCC RECEIVES NATIONAL HONOR FOR COMMITMENT TO FIRST-GENERATION STUDENT SUCCESS

BMCC was included in the inaugural cohort of the First Forward Institutions, an initiative of the Center for First-generation Student Success. BMCC was one of just three two-year institutions among the 80 colleges selected to join the cohort. The First Forward designation recognizes higher learning institutions that have demonstrated a commitment to improving experiences and advancing outcomes of first-generation college students. Institutions selected to the cohort will receive professional development, community-building experiences and a first look at the Center’s research and resources. At BMCC, more than 53 percent of students are the first in their family to attend college, according to data gathered from financial aid applications. A growing body of research suggests that a combination of simple nudges and check-ins with a mentor helps first-generation students feel more confident about navigating the maze of college life.

BMCC WINS NATIONAL RECOGNITION FOR INNOVATION

BMCC is one of 58 colleges nationwide—the only college in New York City, and one of two in New York state—to receive the 2019 Innovation of the Year Award from the League for Innovation in the Community College, a non-profit organization that supports transformational innovation within and across colleges and international borders. The award recognizes the BMCC Faculty Leadership Fellows Program, which seeks to recognize and develop faculty leadership, advance departmental and college priorities, and promote the role of community colleges more broadly in society.

SECONDARY EDUCATION FOR SOCIAL STUDIES MAJOR MEETS GROWING DEMAND

Starting Fall 2019, students at BMCC will have the option of earning an Associate in Arts degree in Secondary Education for Social Studies (SESS) through the Teacher Education Department. The SESS program meets a need within BMCC and New York City itself. The SESS associate degree program at BMCC will articulate with the Bachelor's of Arts in Adolescent Social Studies program, at Hunter College, CUNY. Graduates who earn their associate degree in Secondary Education for Social Studies, followed by a bachelor's degree at Hunter College, can go on to earn additional degrees that would position them to work in colleges and universities.

TEXTBOOK-FREE CRIMINAL JUSTICE DEGREE HELPS STUDENTS SAVE

BMCC students majoring in criminal justice can now potentially complete the degree program without ever having to buy a textbook, saving altogether, an estimated \$2,500. BMCC faculty have redesigned 20 courses to create an Open Educational Resources (OER) criminal justice associate degree. The effort was funded by a 2016, two-year OER grant from the organization Achieving the Dream. This milestone was reached through the efforts of criminal justice faculty as well as professors in core courses such as mathematics. A number of faculty who worked to bring the OER criminal justice degree to fruition—the first OER associate degree program at BMCC—say the process was filled with challenges yet ultimately was energizing.

BMCC MOURNS THE LOSS OF LONG-TIME COLLEGE COMMUNITY LEADERS



SADIE BRAGG

Sadie Bragg, who served as provost and senior vice president of academic affairs at BMCC until her retirement in 2014, passed away on Wednesday, October 31, 2018. Dr. Bragg earned an M.A. and Ed.D. from Teachers College, Columbia University, and joined BMCC in 1970 as a mathematics lecturer in the Manhattan Opportunity Center (MEOC). In 1982, she joined the faculty of the BMCC mathematics department and in 1989, became the college's associate dean of academic affairs for curriculum and instruction. In 1996, Dr. Bragg was promoted to the role of vice president of academic affairs and in 2014, she retired as provost and senior vice president of academic affairs.

Dr. Bragg served under five BMCC presidents, and her longest tenure was with Dr. Antonio Pérez, president of BMCC from 1995 to August 2018. "Sadie Bragg was totally dedicated to the college and ensuring that our students had all the opportunities to succeed," said Dr. Pérez. "She was an accomplished mathematician, author, loyal colleague and friend."



G. SCOTT ANDERSON

BMCC's former vice president of administration and planning Granville Scott Anderson passed away on June 13, 2019. Mr. Anderson began his service to CUNY in 1971, and joined BMCC in 1994. He distinguished himself as a hardworking, hard-driving, invaluable and forward-looking administrator. Mr. Anderson was a graduate of the City University of New York. He received an associate of arts degree from Queensborough Community College in 1971. He went on to earn his Bachelor of Arts degree in Political Science from Queens College. In 1996, he received his Masters in Higher Education Administration degree from Baruch College. Mr. Anderson fearlessly led BMCC through the facilities and budgeting challenges presented as a result of

9/11 and the loss of Fiterman Hall. Within three weeks after 9/11, he and BMCC's B&G staff had 199 Chambers Street ready for returning students. Mr. Anderson was at the center of the battle to get a building erected to replace the destroyed Fiterman Hall building and the 2012–2013 academic year was launched with the opening of the Miles and Shirley Fiterman Hall. Mr. Anderson never allowed any challenge to deter him from finding a solution that was in the best interest of the college. His leadership, sense of humor, concern for the well-being of our students and determination to make BMCC a great institution will be greatly missed.
